### **How is my personal information protected?**

## **Does ECKANKAR Society of Central Australia share my personal information with others?**

ECKANKAR Society of Central Australia does not share your personal information with others except in the following case:

leaders of Eckankar to fulfil your requests, administer contact lists, and coordinate activities. All such recipients sign a data-privacy agreement and may only process your personal data for the purposes given in this Privacy Policy and according to local law.

- Access logs

Like all web servers, our web server automatically creates access logs for every visit to our site. Access logs include the time of your visit, the type of browser you are using, the IP address for the computer you are visiting from, and the Web page you came from. We analyse these logs to help us improve the user experience. We also use Google Analytics for the same purpose.

The IP address is not associated with any personally identifying information unless (1) you have filled out any forms on and (2) it is necessary to research possible harmful or illegal conduct in

connection with the use of our websites, or to comply with the law.
